## Approved Treatment Protocol for Intra Quarantine Movement of Regulated Nursery Stock



Plant Industry Division

Regulated nursery stock must be treated with both a systemic (Table 1) and foliar (Table 2) pesticide to move within the area quarantined for Asian Citrus Psyllid (ACP) for the specified certification period and records (as prescribed in the ACP compliance agreement) of the treatment maintained for review by the Nevada Department of Agriculture (NDA).

Tables 1 and 2 below, list the products approved by the NDA as quarantine treatments for intra quarantine movement of host nursery stock for the Asian Citrus Psyllid Interior Quarantine.

It is incumbent upon the user to follow all label directions when using any of the products listed below for quarantine certification purposes. Apply product at label rates listed for psyllids. If psyllid is not listed, contact the NDA. Please reference the NDA's pesticide regulation website to obtain product and label information, including site use (production vs. retail) at agri.nv.gov/pest-control.
