## **Livestock Brand Transfer Application**

## **Dear Brand Holder:**

The Nevada Department of Agriculture (NDA) Division of Animal Industry is charged by law to protect the interest of registered brand owners of record and, therefore, cannot add, delete or change ownership without supporting legal documents authorizing us to do so.

If you wish to change the name(s) of the owner(s) of a particular brand, you must complete a Transfer of Title Form and submit \$235.00 for fees (\$35 application fee + \$200 brand recording fee).

The only changes that do not require payment of fees are:

- a. Legal proof of name change, i.e. adoption, preference of name, etc.
- b. Removing name of parent, or guardian, upon reaching the age of 18. Notification in writing with a copy of birth certificate or driver's license.
- c. A woman who is the sole owner may change the owner's name of record to her married name by submitting a certified copy of the Marriage Certificate.
- d. If a brand is held in "Joint Tenancy with Right of Survivorship," a copy of the Death Certificate of the deceased is required. Brand Recording must show name of owners as "Joint Tenants."

In case of death, an application for Transfer of Title may be signed by the Administrator acting on behalf of the estate of the deceased brand owner, or by the heir(s) to the brand. A certified copy of the deceased's Death Certificate must accompany the Transfer of Title and documentation of the Administrator's appointment to act on the deceased's behalf.
