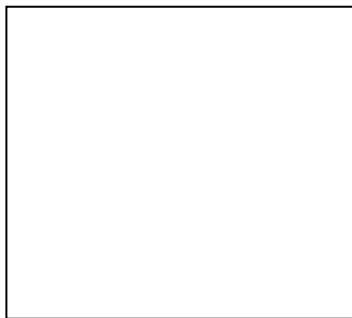

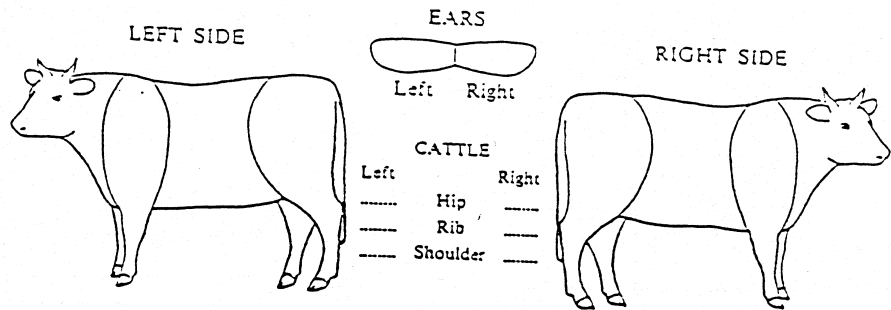

INSTRUCTIONS

In accordance with NRS 564.020

(2). It shall be unlawful for any owner of such animals to brand or brand and mark, or cause to be branded or branded and marked, his animals with a brand or brand and mark not at the time of legal record as provided in this chapter.

(3). It shall be unlawful for any owner of such animals to use an earmark which involves the removal of more than one-half of the ear, measuring from the extreme tip of the ear to the head, or which brings the ear to a point by removing both edges of the ear.

In accordance with NRS 564.025 (3) owners of animals coming into Nevada from another state to graze upon the open range must have a brand registered in Nevada.

- 1. Limited to out-of-state owners of animals brought into Nevada to graze.**
- 2. Applicants will be assessed a \$35 application fee and a recording fee of \$50.00 per year, per brand. The brand is renewable on an annual basis.**
- 3. Fill out application completely.**
- 4. Attach copy of brand recording in home state showing expiration date.**
