- Obtaining a pesticide applicator certificate will allow you to apply and supervise the use of restricted use pesticides. It is not a license to apply any pesticide for hire.
- A one day training program will be held on October 9th. The fee for the training is **\$40.00** and is payable to the Nevada Weed Management Association (WMA) when you register for the conference. The training fee is in addition to the WMA conference registration.
- Testing will be held on October 10, at 8:00 am. ***Please note: the test will be given concurrently during the morning program of the Weed Management Association. If you take the test you will miss the first portion of the WMA meeting on October 10th. No testing will be done on October 9th.*** A test fee of **\$25.00** (cash or check payable to the NDOA) will be collected on October 10th before the certification tests are given. **CAN NOT PAY FOR THE TEST BEFORE OCTOBER 10TH**. If you wish to receive training at the conference and test at another time you may take the test, by appointment only, at the Nevada Department of Agriculture office in Las Vegas by calling (702) 486-4690.
