Las Vegas:

Dona Fong – Las Vegas resident, horses are in dire need of help from NDA and advocates. Asks that NDA enter into cooperative agreement with Virginia Range Sanctuary.

Sparks:

Deb Walker, AWHC – referenced documents attached to board packet from AWHC. Asks that fertility control be restarted.

Suzanne Baker, WHCL - restart fertility control. Less land and more horses.

Nancy Kilian, VRWPA – requesting short term interim contract for birth control with VRWPA. All funded by donations, no down side to the state.

Liz MacMenamin, Retail Association of Nevada – State is proposing an egregious amount in fee increases, asks that discussions on the matter continue.

Dr. Lori Ugolik – against culling for horse population. Need to work together with a cooperative agreement. Patricia Ackerman – 86% of people in Nevada are in support of the horses. Cannot find rational explanation as to why AWHC program isn't implemented. No downside to restarting fertility control.

Tracy Wilson, HVWHPF – unified group of advocate organizations are working together. Board and NDA need to look internally at why these problems started.

Deb Armstrong, VRS – Urges NDA to put a viable management solution in place. The reason for past failed agreements is because of the group, not the agreement. VRS can work well with NDA.

Dr. Pat Colletti, VRS – VRS focuses on more issues than just birth control. The range is changing. Eco tourism is an important component to the issue.

Shannon Windle, HVWHPF – Listed the local, city, government, private groups that advocates have been working with. Feels that it should be NDA working with these groups.

Ray Atwood – spoke in support of VRS.

Colette Kaluza – no group affiliation, concerned citizen. Horses are good for tourism. Public loves the horses. Requests that the board enter into a cooperative agreement with AWHC.

Therese Kline – we all have a common goal, but we're paralyzed about the best plan of action.

Marty Wright – spoke on the recent horse relocation, some horses given to prison are healthy and young and



they were stolen from the range, which is unfair.

Louise Martin – Regarding pzp birth control, it is well documented and successful. BLM currently has partnerships with 5 states for pzp darting.

Anna Orchard – there have been lies and misinformation spread by advocate groups. VRS can work well with the NDA.
