SUMMARY—Makes various changes relating to wildlife. (BDR 45-362)

FISCAL NOTE: Effect on Local Government: No. Effect on the State: Yes.

EXPLANATION - Matter in *bolded italics* is new; matter between brackets for its material is material to be omitted.

AN ACT relating to wildlife; revising provisions relating to the fees charged to an applicant for an elk tag; making various other changes relating to wildlife; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law sets forth the fees to be charged by the Department of Wildlife to a 1 234 56 hunter who applies for an elk tag. In addition to a fee for the tag itself, the Department is required to charge a fee for processing the application of not more than \$15, of which \$5 must be used for the prevention and mitigation of damage caused by elk or game mammals not native to this State. (NRS 502.250) Section 3 of this bill revises those provisions so that the fee for processing the application is ž fixed at \$10 and the fee to cover costs of prevention and mitigation is increased to not more than \$10, as provided by regulation of the Board of Wildlife Commissioners. Sections 1 and 2 of this bill make conforming changes. 8

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. NRS 501.356 is hereby amended to read as follows: 1 2
 - 501.356 1. Money received by the Department from:

(b) Fees pursuant to the provisions of NRS 488.075 and 4 5 488.1795:





(c) Remittances from the State Treasurer pursuant to the 1 2 provisions of NRS 365.535;

(d) Appropriations made by the Legislature; and

(e) All other sources, including, without limitation, the Federal 4 Government, except money derived from the forfeiture of any 5 property described in NRS 501.3857 or money deposited in the 6 Wildlife Heritage Trust Account pursuant to NRS 501.3575, the 7 Wildlife Trust Fund pursuant to NRS 501.3585, the Energy 8 9 Planning and Conservation Account created by NRS 701.630 or the Account for the Recovery of Costs created by NRS 701.640, 10

→ must be deposited with the State Treasurer for credit to the 11 12 Wildlife Fund Account in the State General Fund.

13 2. The interest and income earned on the money in the Wildlife 14 Fund Account, after deducting any applicable charges, must be 15 credited to the Account.

16 3. Except as otherwise provided in subsection 4 and NRS 17 503.597, the Department may use money in the Wildlife Fund 18 Account only to carry out the provisions of this title and chapter 488 of NRS and as provided in NRS 365.535, and the money must not 19 20 be diverted to any other use.

4. Except as otherwise provided in NRS 502.250 and 504.155, 21 22 all fees for the sale or issuance of stamps, tags, permits and licenses that are required to be deposited in the Wildlife Fund Account 23 24 pursuant to the provisions of this title and any matching money 25 received by the Department from any source must be accounted for 26 separately and must be used: 27

(a) Only for the management of wildlife; and

28 (b) If the fee is for the sale or issuance of a license, permit or tag 29 other than a tag specified in subsection 5 [or 6], 7 or 8 of NRS 30 502.250, under the guidance of the Commission pursuant to 31 subsection 2 of NRS 501.181. 32

Sec. 2. NRS 502.142 is hereby amended to read as follows:

502.142 1. The Commission shall adopt regulations to 33 establish a program pursuant to which the Department will issue 34 35 special incentive elk tags. The regulations must:

36 (a) Set forth the application and annual review processes for the 37 issuance of special incentive elk tags.

(b) Require that an application for a special incentive elk tag 38 39 must be accompanied by:

40 (1) The fee charged for an elk tag pursuant to *subsection 1 of* 41 NRS 502.250: and

(2) Any administrative fee charged in connection with the 42 issuance of an elk tag pursuant to this chapter [.], including, 43 44 without limitation, the fees charged pursuant to subsections 4 and 45 6 of NRS 502.250.





1 (c) Provide for the issuance of a special incentive elk tag only to 2 a person who:

3 (1) Lawfully owns, leases or manages private land within an 4 actual elk use area; and

5 (2) If that private land blocks reasonable access to adjacent 6 public land, provides reasonable access through the private land to 7 allow a person or hunting party possessing a valid elk tag to hunt elk 8 on the adjacent public land.

9 (d) Establish criteria for the issuance of special incentive elk 10 tags based upon:

11 (1) The number of elk using private land controlled by the 12 applicant;

13 (2) The number of days the elk use private lands of the 14 applicant in a calendar year;

15

(3) The total number of elk; and

16 (4) Limiting the number of special incentive elk tags issued 17 in each calendar year to not more than one-half of the bull elk tags 18 issued in that calendar year,

19 \rightarrow within the actual elk use area in the unit or units of the 20 management area or areas in which the private land is located.

21 (e) Provide that special incentive elk tags are valid for both 22 sexes of elk.

(f) Prohibit a person who has, within a particular calendar year,
applied for or received compensation pursuant to NRS 504.165 as
reimbursement for damage caused by elk to private land from
applying, within the same calendar year, for a special incentive elk
tag for the same private land.

(g) Allow a group of owners, lessees and managers of private
land to qualify for a special incentive elk tag for their combined
lands.

(h) Ensure that the issuance of special incentive elk tags will not
result in the number of bull elk tags issued in any year being
reduced to a number below the quota for bull elk tags established by
the Commission for 1997.

(i) Provide that a person to whom a special incentive elk tag isissued by the Commission pursuant to this section may:

(1) If the person holds a valid hunting license issued by this
State, use the special incentive elk tag himself or herself; or

39 (2) Sell the special incentive elk tag to another person who40 holds a valid hunting license issued by this State at any price upon41 which the parties mutually agree.

42 (j) Require that a person who is issued a special incentive elk tag 43 must hunt:

(1) During the open season for elk.

Any fee collected pursuant to this subsection 38 must be deposited with the State Treasurer for credit to the Wildlife 39 Fund Account in the State General Fund . [and used for the 40 prevention and mitigation of damage caused by elk or game 41 mammals not native to this State.]

42 **5.** A fee of not less than \$15 and not more than \$50 must be 43 charged for processing an application for a Silver State Tag.



1 [5.] Any fee collected pursuant to this subsection must be 2 deposited with the State Treasurer for credit to the Wildlife 3 Heritage Trust Account in the State General Fund.

6. If an application is for an elk, in addition to the fee for the 4 elk tag required by subsection 1 and the fee for processing an 5 6 application required by subsection 4 or 5, a fee of not less than \$5 and not more than \$10, as provided by regulation of the 7 Commission, must be charged. Any fee collected pursuant to this 8 9 subsection must be deposited with the State Treasurer for credit to 10 the Wildlife Fund Account in the State General Fund and used pursuant to NRS 504.155 for the prevention and mitigation of 11 12 damage caused by elk or game mammals not native to this State.

13 The Commission may accept sealed bids for, or award 7. 14 through an auction or a Silver State Tag Drawing, or any 15 combination thereof, not more than 15 big game tags and not more 16 than 5 wild turkey tags each year. To reimburse the Department for the cost of managing wildlife and administering and conducting the 17 bid, auction or Silver State Tag Drawing, not more than 18 percent 18 of the total amount of money received from the bid, auction or 19 20 Silver State Tag Drawing may be deposited with the State Treasurer 21 for credit to the Wildlife Fund Account in the State General Fund. Any amount of money received from the bid, auction or Silver State 22 23 Tag Drawing that is not so deposited must be deposited with the 24 State Treasurer for credit to the Wildlife Heritage Trust Account in 25 the State General Fund in accordance with the provisions of 26 NRS 501.3575.

27 The Commission may by regulation establish an [6.] 8. 28 additional drawing for big game tags, which may be entitled the Partnership in Wildlife Drawing. To reimburse the Department for 29 30 the cost of managing wildlife and administering and conducting the 31 drawing, not more than 18 percent of the total amount of money received from the drawing may be deposited with the State 32 33 Treasurer for credit to the Wildlife Fund Account in the State General Fund. Except as otherwise provided by regulations adopted 34 by the Commission pursuant to subsection [7,] 9, the money 35 36 received by the Department from applicants in the drawing who are 37 not awarded big game tags must be deposited with the State 38 Treasurer for credit to the Wildlife Heritage Trust Account in 39 accordance with the provisions of NRS 501.3575.

40 **[7.]** 9. The Commission may adopt regulations which 41 authorize the return of all or a portion of any fee collected from a 42 person pursuant to the provisions of this section.
