A. *Adopt regulation LCB File No. R085-15 A REGULATION relating to industrial hemp; establishing provisions relating to the certification and registration of sites used for growing or cultivating industrial hemp; and providing other matters properly relating thereto. – Robert Little, Division Administrator (*for possible action*)

Dave Stix, Jr. moves to adopt regulation LCB Fire No. R085-15. Charlie Frey seconds. Motion passes unanimously.

Robert Little updates the board on next steps - LCB for Secretary State to sign off potentially on March 11, 2016. DEA permit should be received shortly to allow the NDA to receive certified hemp seed imported from Canada. Applications should be received in the next few weeks to allow for a one-lump seed order. The NDA requested an expedited budget approval from State Budget to allow the NDA to build the budget account. This will allow the NDA to accept growers' application fees. The NDA is doing our due diligence to meet a June 1, 2016 growing season.
