1-Call to order, roll call of members and establish a quorum

4-Correspondence

The correspondence that was received was discussed under item 8-a, Exhibitor Sale Conflict Requests.

8-2014 Show

a. Exhibitor Sale Conflict Requests

-A request from Isaac Qualls asking to show another exhibitor's lamb in showmanship due to the death of his lamb was received. Mr. Miller moved to allow Isaac Qualls to show another exhibitors lamb for showmanship, seconded by Mr. Cates. The motion was passed

- -A request from Julie Hamilton asking for another member of the Bouncing Bunnies club to sell her meat pen rabbits at the auction due to it conflicting with a school event was received. Ms. Chvilicek moved to allow another exhibitor to sell her meat pen rabbits, seconded by Mr. Miller. The motion was passed.
- -A request was received from Ben Barnard asking to be excused from showing his market lamb and allowing his brother to show them on Friday, May 16th and Saturday, May 17th due to it conflicting with his school baseball program. He would only need to miss if his team has yet to be eliminated from playoffs. Mr. Miller moved to approve excusing Ben Barnard if his baseball schedule conflicts with the show, seconded by Mr. Cates. The motion was passed.
- -A request from Kasey Williams was received asking to allow another member of Douglas County 4-H to sell her animal at the auction due to it conflicting with an Armed Forces Day Parade at her high school. Ms. Chvilicek moved to approve another member of the club to sell her animal at auction, seconded by Mr. Miller. The motion was passed.
- -A request from Hannah Winans was received informing the board that due to medical reasons she would not able to handle her lamb in the arena. She asked that a fellow FFA member be allowed to show her lamb. Ms. Elston moved to approve allowing a fellow FFA member to show the lamb, seconded by Mr. Cates. The motion was passed.
- -A request was received asking that Angelina Irby be allowed to show Kiley Woolsey's goat in novice showmanship because her goat died. Kiley Woolsey requested that she be moved from Novice Showmanship to Senior Showmanship to accommodate Angelina Irby. Ms. Chvilicek moved to approve allowing Kiley Woolsey to move to Senior Showmanship in order for Angelina to show in Novice Showmanship, seconded by Mr. Miller. The motion was passed.
- -A request was received from Dario and Dominic Ceresola asking they be allowed to have their brother walk their animals in the auction due to a conflict with a school activity. Mr. Miller moved to approve allowing their brother to walk their animals during the auction, seconded by Ms. Chvilicek.

b. Rate of Gain Awards

Mr. Hellwinkel informed the board that there was currently \$295 for Rate of Gain awards. He asked for \$5 to make it an even \$300. Ms. Chvilicek moved to approve giving \$5 to the Rate of Gain Awards, seconded by Ms. Elston. The motion was passed.
