Proposed 2017 Rules for NJLS Board Consideration Nov. 14, 2016, support material to 11/14/16 Agenda

NOTE: All needed date changes, grammar/spelling corrections and consistency will be made prior to publishing 2017 Rules.

Page 5 – added to end of current paragraph relating to Breeding Animals: ***Exhibitors cannot combine breeding animal entries to create group class entries***

Page 6 – Dress Requirements – Add the following at the end of the current paragraph: ***If an exhibitor does not meet the minimum dress requirements that exhibitor may not enter the show ring (example for consideration – “no distressed jeans”)***

Page 9 – Added to section on Market Show Entries: ***1) All Champion and Reserve Champion Animals must sell at the NJLS Market Sale.***
2) An exhibitor may choose one club/chapter to show in Market and another club/chapter for Breeding; provided they are members of both club/chapter. An exhibitor may not show a market animal in one club/chapter and a second market animal in another club/chapter. (Example for clarification/consideration – a member shows a market steer as a 4-H Member and shows a market lamb as a FFA member.) – Exhibitor who is enrolled in both 4-H and FFA (or other allowed exhibitor classification) must declare their 4-H Club and FFA Chapter.

Page 10 – Added to section on Breeding Show Entries: ***All group class entries must be owned by a single exhibitor, exhibitors cannot combine breeding animal entries to create group class entries.***

Page 11 – Added to section on Release of Entries: ***Live release animals includes all species of breeding animals.***

Page 14 – Added to section on Livestock Sale Rules: ***All Champion and Reserve Champion Animals must sell.***
Exhibitors who do not have a picture taken of themselves and their market project animal – If no picture the exhibitor will be barred from the sale – No Picture No Sale.
All market animals at time of sale must be presented clean. If animals are dirty or soiled with manure they must be clean before entering the sale arena.

Page 17 – Add-ons: ***enforce \$25 minimum, no exceptions for any market species (clarification for consideration, market rabbit add-ons must be minimum of \$25)***

Page 24 – Dates for Rabbits: ***Rabbits must not be born before March 8, 2017. Entry form due April 15, 2017, Ownership date April 15, 2017.***

Page 26 – added to section on Market Rabbits: ***Due to funding of the show and the number of entries remove class 89 – meat pen and only offer class 90 – Single Fryer***

Page 28 – The NJLS Board need to address the following: ***Remove Prospect Lamb Class 97 and only offer Feeder Class 98 – all feeder lambs will be shown and classes offered by weight.***

Page 37 – Revisions to Nevada Junior Livestock Show Scholarships: application requirements: ***Need to submit one (1) original and three (3) copies.***

Page 38 – In section discussion on amount of scholarship: suggested new wording: ***For each scholarship in the amount of \$1000 or more, one half of the award will be distributed in each of two successive semesters or quarters. Scholarships less than \$1000 will be made in one payment, provided the blow criteria are met.***

Delete the reference in third paragraph of requirements: copy of receipt of class fees paid for that period

Last line should read: Transcripts must include student's name and student ID number

The NJLS Board is asked to consider ***reinstating the Achievement in Record Keeping Contest.***

Page 38 – Dairy Goats – ***the board is asked to consider removing the Dairy Goat Show from probationary status.***

Page 39 – change pair of females to ***pair of Does***
