**PROPOSED REGULATION OF THE DIRECTOR  
OF THE STATE DEPARTMENT OF AGRICULTURE**

EXPLANATION – Matter in *italics* is new; matter in brackets [~~omitted material~~] is material to be omitted.

AUTHORITY: §1, NRS 565.040.

A REGULATION relating to brand inspection districts; changing the number and boundaries of brand inspection districts in this State; and providing other matters properly relating thereto.


**Legislative Counsel's Digest:**

Existing law authorizes the Director of the State Department of Agriculture to declare any part of this State a brand inspection district and the boundaries of any brand inspection must be defined in regulations adopted by the Director. (NRS 565.040) Existing regulation defines the boundaries of 10 brand inspection districts covering the entire territory of this State. (NAC 565.210) This regulation eliminates the 10 existing districts and defines the boundaries of 4 new brand inspection districts.

**Section 1.** NAC 565.210 is hereby amended to read as follows:

565.210 1. The areas designated as districts and assigned numbers by the Director are those areas and numbers marked on the following map:
