The Nevada Department of Agriculture, 405 South 21st Street, Sparks, Nevada, 89431, is proposing the Amendment of regulations pertaining to chapter NAC 586 of Nevada Administrative Code. A workshop has been set for 10:00 A.M. on Tuesday, February 19, 2013 at:

The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

NAC 586.011 Annual Registration fee: Amount; deposit and use of portion of fee

The Department is proposing a fee increase to support departmental infrastructure and the noxious weed program set aside to more effectively participate in the state's protection of sage grouse in an attempt to prevent the species being listed as threatened and endangered. The current fee for pesticide registration in Nevada is \$100 per product; we are proposing an increase to \$150 per product; surrounding states currently charge from \$750 per product (California) to \$100 per product (Arizona).
