PUBLIC WEIGHMASTER'S BOND

Know All Men By These Presents:

That We, _____, having a principal place of business at _____, Nevada (hereinafter called the principal), as principal, and _____, a corporation organized under the laws of _____, and fully authorized to transact business in the State of Nevada (hereinafter called the surety), are held and firmly bound to the State of Nevada in favor of any recipient of a Public Weighmaster's Certificate issued by the licensee in the sum of One Thousand Dollars (\$1,000) for the payment of which, well and truly to be made, we bind ourselves, our heirs, executors, successors, and assigns, jointly and severally, firmly by these presents.

THE CONDITION of the above obligation is such, that whereas the above named principal has applied to the Department of Agriculture of the State of Nevada for a license entitling said principal to conduct the business of Public Weighmaster in accordance with the provisions of sections 582.010 to 582.180, inclusive, Nevada Revised Statutes.

NOW, THEREFORE, if said principal shall well and truly comply with the provisions of sections 582.010 to 582.180, inclusive, of the Nevada Revised Statutes, and also any all future amendments thereto, and rules and regulations thereunder, then this obligation is to be void; otherwise to remain in full force and effect. This bond shall be deemed continuous in form and shall remain in full force and effect unless and until terminated or canceled in the manner hereinafter provided.

PROVIDED, HOWEVER, and it is hereby expressly understood and agreed, that nothing herein contained shall be deemed or construed to reduce the liability hereunder below the sum of One Thousand Dollars (\$1,000) for the period for which the principal holds a license as a Public Weighmaster in the State of Nevada.

IT IS EXPRESSLY understood and agreed that the liability of the surety hereon to any and all persons shall not exceed in the aggregate the sum of One Thousand Dollars (\$1,000) for each 12-month period commencing from the date of license issuance.

IT IS FURTHER provided that the surety herein shall have the right to withdraw as surety from this bond, except as to any liability already incurred or accrued; and may do so upon giving the said principal and the Department of Agriculture of the State of Nevada thirty (30) days' written notice to that effect, and at the end of said 30-day period of notice the liability of the surety under this bond, except as to any liabilities or indebtedness already incurred or accrued, shall cease and said bond shall thereupon terminate and be of no more force or effect, except as to any liabilities or indebtedness already incurred or accrued thereunder.
