

**2021 Business Impact Survey on Proposed  
changes to NAC 587**  
Plant Industry Division



**Overview of Survey Administration:**

The Nevada Department of Agriculture (NDA) launched this survey on June 24, 2021. The survey was closed on 7/13/2021 at 8:00 AM. The survey was administered using electronic communications through MailChimp, Survey Monkey, and Outlook. These survey notices were sent to the Nevada agriculture industry, industry advocacy groups, and those who have requested to receive notices and communications from the NDA. Initially this list was emailed to 4,108 nurseries and businesses potentially buying or selling seed in Nevada. Out of the 4,108 emails sent out via Survey Monkey 1,307 were opened, 1,949 were unopened, 635 bounced, and 217 emails were declined as they were on our department opt-out list. A reminder email was sent via Survey Monkey on June 30, 2021 to 3,247 contacts who had initially started the survey, or those who hadn't opened the original email.

In addition to being sent out via Survey Monkey on June 24, 2021 the survey was posted to [Agri.nv.gov/survey](http://Agri.nv.gov/survey). The survey was promoted in NDA social media on July 6, 2021, July 8, 2021, and July 11, 2021. In addition to this promotion the Nevada Farm Bureau sent it out in their weekly member newsletter on July 9, 2021 and on July 2, 2021.

On July 6, 2021 this survey was sent out to the NDA's all agriculture email list. This list is comprised of 7,195 recipients comprised of businesses and parties interested in agriculture within the State of Nevada. Of these recipients 2,270 opened the email, 132 recipients clicked links in the email, 62 emails bounced, and 8 recipients unsubscribed.


**Survey Response Rate:**

In total this survey received 44 responses with a 59% survey completion rate. 20 responses were received through the original Survey Monkey email. 24 responses were received through social media, mail chimp, website postings, and other survey promotion.

**Survey Results:**

Figure 1. Does your business fall under the definition of a small business as defined by NRS 233B.0382




Figure 2. If enacted would the proposed changes to NAC 587 impact your ability to do business?

I sell packaged seeds. If they don't grow, customers will stop buying them. Its that easy. You can test more or not test at all. Adding cost to seeds is silly.



**Q4. Please estimate the total annual impact the proposed changes to NAC 571 will have on your business.**



**Figure 7. Please estimate the total annual impact the proposed changes to NAC 587 will have on your business?**




Reported cost of the proposed changes to NAC 587 on small business would be between \$34,307 and >\$63,099 based upon the ranges reported by respondents. However, the median cost to individual small businesses indicates there would be no additional cost to operations.

In total 13 respondents (52. %) reported that there would be no cost due to NAC 587. While 12 respondents (48%) reported they would incur costs as a result of the proposed regulations. In total 8 respondents (32%) stated that they would incur costs greater than \$1,000.

Figure 8. What level of negative impact will the proposed changes to NAC 587 have on your business?




Figure 11. Respondents who identified as a small business: (11 respondents, 24 skipped)


Figure 11. If enacted would the proposed changes to NAC 571 impact your ability to do business?


Figure 18. Respondents who did not identify as a small business: (1 respondents, 8 skipped)


**Q11. In which county is your business primarily located? (25 respondents, 19 skipped)**

**Figure 19. In which county is your business primarily located? (All respondents)**




