

Division Overview/Program Updates

Seed

- To promote native seed as an alternative crop opportunity, the Nevada Department of Agriculture (NDA) Seed Program, in collaboration with the Nevada Division of Forestry (NDF), hosted its Third Native Seed Road Show at the Washoe State Tree Nursery on April 30, 2024. The event featured the NDF Nursery Program and educated participants on various aspects of the native seed industry.
- NDA Seed Program collaborated with Federal Seeds of Success (SOS) partners to provide seed certification training for incoming SOS collections crews. This training enabled crew members to better understand the complexities of seed certification and will provide SOS collectors and NDA staff with the ability to streamline the service. NDA expects an increase in Source Identified-SOS collections for the 2024 season.

Pesticide Program

Operators

• Pesticide program staff met with a representative from the Nevada Human Development Corporation (NHDC) regarding farm worker safety and education in Nevada. NHDC is interested in looking for ways to provide support and education to farms through various training and seminars. They focus on assisting farm workers with vocational training, on-the-Job training, training-related support services, counseling and case management. The representative is going to accompany NDA's Worker Protection Standard (WPS) Specialist since our goals and services are somewhat aligned.

Pesticide Complaint Investigations

• NDA Pesticide inspection staff are responsible for following up on concerns regarding possible pesticide misuse complaints. On occasion, staff will receive complaints regarding pesticide drift, unlicensed activity, applying in adverse weather conditions, label misuse, dumping, etc., of which some are received via the Nevada Division of Environmental Protection (NDEP) or via the Environmental Protection Agency (EPA). Crop

Hemp

- NDA coordinated with the Nevada Farm Service Agency (FSA) to ensure that growers completed their crop reporting through FSA. This is a federal requirement.
- NDA submitted a draft Hemp State Plan to the United States Department of Agriculture (USDA) for review in hopes of submitting a final plan for adoption by end of the fiscal year.

• The following data reflects hemp samples collected by the NDA and tested for federal compliance, above compliance, and approved crop disposals of non-compliant crops between July 1, 2023 and April 30, 2024.

Export/Phytosanitary Inspections

- At the beginning of 2024 we received a request for potato export phytosanitary inspections that are going to Mexico. Currently we have one (1) inspector in Winnemucca two (2) times a week inspecting potatoes equating to five to eight trucks a day available for shipment. We started inspections at the end of January and will be ongoing potentially until July 2024.
- As of July 1, 2023 through April 30, 2024, 613 federal and state Phytosanitary Certificates have been issued.
- Other items certified for export, that are not measured by weight, but by count totaled 37,144 and included nursery stock and hay.
- The department currently has four (4) agriculturists certified as onion inspectors.
- The department has three newly certified Authorized Certification Officials (ACOs) that completed training on April 24, 2024.

Noxious Weeds

Regulatory Actions

• The NDA noxious weed team has begun to pick up regulatory efforts for Spring. NDA staff met with Spring Creek HOA staff on May 2, 2024 to coordinate regulatory outreach letter efforts. Other follow-up efforts include addressing Swainsonpea and Yellow Starthistle in Humboldt County, African Rue in Churchill county and Yellow Starthistle in Washoe county.

Nevada's Early Detection and Rapid Response (EDRR) Plan

• Nevada's EDRR plan continues to move forward. The NDA noxious weed team hosted the state meeting on February 28, 2024 and regional meetings took place in March.

Outreach and Education

- The NDA noxious weed team has participated in 24 events for FY24 and has a few more planned for the summer that will wrap up the fiscal year. Weed Free
- Weed free forage inspections will increase during first cuts around the end of May. It is anticipated that the Weed Free Certificates issued will increase as well.

Biological Control

- The NDA biological control program did begin rearing efforts to increase the availability of Russian Knapweed agent *Jaapillea ivannikovi* in the state.
- Noxious weed staff will be attending the 2024 National Forum on Biological Control.
- NDA successfully hosted the Nevada Strategic Weed Biological Control meeting. Participants traveled from Utah, Idaho, and California and included members from the United States Forest Service (USFS), Bureau of Land Management (BLM),

United States Fish and Wildlife Service (USFWS), Nevada Conservation Districts, Humboldt Watershed Cooperative Weed Management Area (CWMA), and other partners. The goal of this meeting is to reconnect with partners in the state and identify ways to strategically grow a Nevada weed biological control program.

Chemistry

- The Chemistry laboratory of NDA, as authorized by the United States (U.S.) Environmental Protection Agency (EPA) has conducted the specialized nationwide laboratory training. The workshop has 12 pesticide laboratory analysts from across the U.S. and worked on advanced training of laboratory analysts in the many relevant aspects of pesticide compliance, sample collection, handling, processing, analyzing, method selection, equipment operation, data interpretation, and reporting.
- The NDA Hemp program is in the process of getting an initial onsite assessment for the International Organization for Standardization (ISO) 17025 accreditation. The initial accreditation assessment will be conducted soon.

Entomology

- Mormon crickets have been reported in Washoe, Pershing, Churchill, Lander, Eureka, White Pine, Humboldt and Elko Counties.
- This season a total of 500 sites have been surveyed. Ground treatments have been done at 48 sites (all BLM) with carbaryl bait.
- Aerial treatments are planned to start the week of May 20, 2024. Approximately 220,000 acres of BLM and private land have been submitted to USDA Animal and Plant Health Inspection Service (APHIS) Plant Protection Quarantine (PPQ) for approval and contracting. Final acreage will be dependent on funding availability.
- Responded to over 400 reports of crickets and grasshoppers (1).
