#### Legislative

- Bill status and implementation
  - AB 504 Request for spending authority has been approved and staff have begun placing orders for laboratory equipment and law enforcement vehicles.
  - SB 390 Amended the language in NRS 583, authorizing the State Quarantine Officer to adopt regulations regarding mobile poultry processing units. NAC is currently under review to align language and begin accepting applications for processing entities.
  - SB 417 the Board of Agriculture approved, during the September 2019 meeting, NDA staff to proceed with regulation amendments for implementation of SB417, relating to livestock auctions. Staff will begin to move forward with the workshop and hearing process to implement the regulatory amendments.
  - SB 347 NDA staff have implemented changes to the hemp program as described in 2019 SB347, which were established to ensure NDA has a program that aligns with USDA's hemp program requirements as described in the 2018 Farm Bill. Guidance from USDA was released in November and NDA is working through the comment period for the new federal regulations.
