Harvest and processing (cutting and wrapping) fees are the buyer's responsibility.

Please remember harvesting fees are only included in the amount payable to NJLSB. The buyer is responsible for the cutting and wrapping fees charged by the processing facility and are due and payable to that facility upon receipt of the meat.
