AGENDA

1. Sub-committee meeting was called to order by Sarah Chvilicek at 5:06 p.m. Present were Doris Hoskin, board assistant, Brandee Mooneyhan, NV Atty. General's office, Bev Elston, NJLS Board, Lindsay Chichester via phone, Charlie Mann, NJLS Board, Matt McKinney, NJLS Board President, Tonya Dressler, Cara Strasser, and Shelia Story.
2. Public Comment - NONE
3. Discussion of Suggested Rule Changes for the 2018 Show for recommendation to the full NJLS Board– The sub-committee reviewed suggested changes to the NJLS rules for 2019. Specific discussion was on the Youth Quality Care of Animals (YQCA), Lindsay Chichester reported that YQCA is in the second year. New and/or revisions have been made in year 2. Clarification was offered that "test out" options have been added where youth can attempt to test out of a specific unit. In order to pass any unit three modules must be attempted and a score of 80% or better is required. There was also discussion to make YQCA an annual requirement. It was suggested to change the due date for all completion of YQCA to be April 1 of each year.

Additional suggested rule changes were to have all entries, breeding and market, of sheep, swine goats, dairy goats and cattle and turkeys (except rabbits) due March 1, Steer entries are due December 1. No breeding entries will be accepted after March 1. It was also suggested that limits be lifted on entries, youth can tag and enter as many animals they want and pay all associated entry fees. Suggested limits are that only four market animals may be shown with a maximum of two market animals per specie and only one market animal sells (unless all are reserve or champion animals).

It was suggested to reformat rules in two sections; one section will be general rules that will govern all youth livestock shows or exhibitions (per NRS statutes that govern the NJLS Board) and a section specific to rules and classes for the annual NJLS Show and Sale.

Additional suggestions regarding Round Robin, youth and adult conduct during NJLS Show and Sale, Youth Advisory applications be due April 1, and changes to scholarship requirements.

All suggested changes will be forwarded to the full NJLS Board at their next meeting for their consideration.

The Board may remove an item from the agenda or delay discussion relating to an item on the agenda at any time.
