These additional comment periods shall be limited to comments relevant to the agenda item under consideration by the Board.

The Board may remove an item from the agenda or delay discussion relating to an item on the agenda at any time. Pursuant to NRS 241.030, the Board may close a meeting to consider the character, professional competence, alleged misconduct, or physical or mental health of a person.
