ORDERING: Please FAX or E-mail (ws.psd@usda.gov) all orders using product name, quantity, and price. Please include a mailing address, a phone number, and an E-mail address. If faxing or E-mailing your order is not an option, please mail your order request. **The PSD will not accept phone orders.** The PSD is not able to do C.O.D. shipments. PSD requires payment prior to the shipment of any products. Customers will need to pay for their purchases via Pay.gov (see <https://pay.gov/paygov/>), a Federal on-line payment tool, or by mailed check. Checks should be made payable to USDA APHIS. Pay.gov enables non-governmental customers to make secure electronic payments to Federal agencies. After you place your order, we will contact you regarding the total amount due, which will include applicable shipping charges. Payments can be made via Pay.gov directly from your bank account through ACH or by credit/debit card. Pay.gov has been a secure form of payment since 2000 and once registered, you can also use it to track your transaction history. If you encounter any difficulties using Pay.gov, please contact Sandy Knutson at Sandra.g.knutson@aphis.usda.gov or call 877-777-2128.

Avoid product deterioration, storage, and possible hazardous-waste disposal problems by ordering only the amount of pesticides that you will actually use. All grain baits should be used within 60 days of purchase to ensure bait acceptance and reduce insect invasion. M-44 cyanide capsules and DRC-1339 concentrate may deteriorate in storage, if improperly stored. The PSD will not reimburse you for the costs associated with hazardous-waste disposal, or for canceled pesticides that you have in inventory and/or did not use.

FREIGHT SHIPPING: Please indicate whether the order is being shipped to a Commercial or Residential destination. Carriers charge less for products shipped by freight to a business title or commercial destination.

WILDLIFE SERVICES: State directors are responsible for ensuring that the pesticides ordered are registered for use in their respective state(s). Orders for restricted use pesticides/products must be approved and signed by the State Director, or their designee. Non-restricted use pesticides may or may not require State Director approval. See pg. 7 for list of states requiring approval. Non-restricted use supplies do not require State Director approval and can be ordered directly from PSD. If ordering pesticides under a 24(c) registration, the order must indicate that, and the PSD must be furnished with the 24(c) label so the pesticide can legally be shipped using the proper label.

PICK-UP ORDERS: Orders can be picked up Monday-Friday 8:00 A.M. – 4:00 P.M. If you request this service, your order will be held for 7 working days only. If the order is not picked up within that time, it will be canceled, and you will have to reorder.

OVERNIGHT ORDERS: The PSD cannot guarantee next-day delivery. Only a few products can be shipped overnight. These products will be shipped via UPS. We highly recommend that you order ahead of time, and give us sufficient time to fill your order. We fill orders on a first-come, first-served basis. NO EXCEPTIONS.

BACK ORDERS: Please understand that back ordered shipments may increase in price due to a price increase in the raw materials used to make our products. This is out of PSD's control.

SPECIAL ORDERS: The quantity made in a special order may be short or over, not to exceed 5%, because of the batch size formulas. PSD will not keep excess amounts.

UPON RECEIPT OF ORDER: Examine all merchandise upon receipt and notify the PSD of any defects or omissions. The PSD must be notified of any omissions or defects within 2 weeks of shipping. A packing slip is included with all orders. Claims for freight loss or damages should be made immediately to the delivering carrier. The PSD will assist you with a claim, if necessary.

RETURNS: The PSD Manager or their designee must pre-approve all returns, exchanges, or refunds. All products must be returned within 45 days. There is a 20% re-stocking fee assessed on all products returned to the Pocatello Supply Depot.

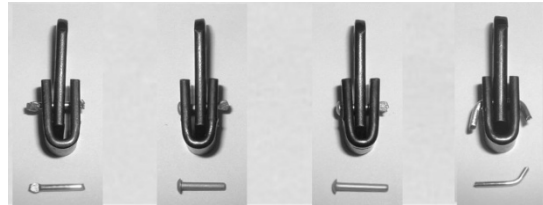

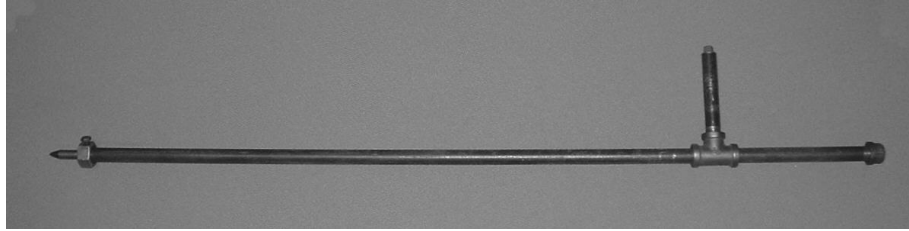

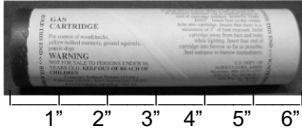

States **REQUIRING APPROVAL** by the **WILDLIFE SERVICES STATE DIRECTOR** for the **RODENT GAS CARTRIDGES** are:
 AZ, CA, CT, DE, IA, KY, MA, MN, MO, NE, NJ, OH, OR, SC, TN, VA, WV.

States that **DO NOT HAVE** the following 4 pesticides registered within their states are: AK, AL, AR, FL, GA, HI, LA, MS, MO, NC, OK, RI, WI. Therefore, they **CANNOT ORDER** them from the Pocatello Supply Depot.
