The following form is used to apply for GARLIC seed certification within the state of Nevada. Certified seed garlic must meet standards set forth within the [Nevada Administrative Code, Chapter 587.640-810](#). When filing this form with the Nevada Department of Agriculture, ensure that all regulatory requirements are reviewed. In addition to filing this application with the Department, the applicant must also submit an “Allium Registration Form.”

INSTRUCTIONS

1. Submit application form by the following date:

Certified Garlic Seed: February 15th

2. Complete and submit an “Allium Registration Form” with this application, if you haven’t already done so.

3. Enclose a detailed field map with the application packet

4. Ensure that form is signed and filled out completely prior to submission
